The resignation has been submitted due to circumstances that may affect or be perceived to affect his independence, following his interest arises in other organisation forming part of the promoter group of the Company in pursuance of Regulation 2(1)(pp)(iii) of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended.

Further, pursuant to his resignation as director of the Company, Mr. Salil Sriram Shetty deemed resigned from all committee positions of the Board, as a member/chairman as applicable. 
Remuneration Committee and the Stakeholder's Relationship Committee of the Board of Bijoy Hans Limited as on the date of this letter.
